ORDINANCE NUMBER 08-2015

AN ORDINANCE OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY, PROVIDING FOR THE REDESIGN OF THE CITY'S WEBSITE AND RELATED EXPENSES AND THE ACQUISITION OF CERTAIN EQUIPMENT AND ITEMS IN AND FOR THE CITY AND APPROPRIATING \$59,300 TO FUND THE SAME.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. For the purpose of the re-design of the City's website and related equipment and expenses, and including expenses incurred in the planning, design and bidding thereof, there is hereby appropriated the sum of \$25,000 from the City's Capital Account.

Section 2. Section 2. For the following purposes, there is hereby appropriated the aggregate sum of \$34,300:

- a. Filing Cabinets for Construction Office in the sum of \$1,800.00;
- b. Filing Cabinets for the Tax Office in the sum of \$1,200.00;
- c. Carpeting for the Construction & Finance Office in the sum of \$4,000.00;
- d. Design and Installation of the Welcome Sign in the amount of \$3,000.00;
- e. Change of Zone, Zoning Ordinances in the amount of \$5,800.00;
- f. Review of Codification of Ordinances in the amount of \$3,500.00; and
- g. Street Scape in the amount of \$15,000.00

Section 3. The capital budget or temporary capital budget (as applicable) of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in

the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. This ordinance shall take effect as provided by law.
