Mayor DelVecchio and City Council Members:

The City of Lambertville Police Department is a progressive, pro-active, community oriented law enforcement agency. We are a full-service department staffed by nine police officers and one special officer that is operational around-the-clock, seven days a week. Primarily a uniformed patrol based operation we also provide a criminal investigative function through the assignment of a detective (when feasible) and conduct periodic specialized patrol in the form of a Bicycle Patrol Unit. Our police officers receive continuous, up-dated in-service training relating to both existing and new policies, procedures, firearms proficiency, and other areas relevant to the law enforcement function. Most of our officers have attended advanced classes, covering many diverse topics that include traffic accident and criminal investigations, Interview and Interrogation, terrorism, Internal Affairs, narcotics enforcement, methods of instruction, Handling the Emotionally Disturbed, Evidence Management, Autism Awareness and computer crime/identity theft. I am proud to say that the caliber of our officers and civilian staff is second to none.

It is the philosophy of this department to perform our duties consistent with modern, community policing practices. We routinely solicit citizen input in addressing crime and quality-of-life issues and always strive to identify and solve problems by maintaining open lines of communication with the community. As public servants we can and should do no less.

I respectfully submit for your review the 2016 Annual Report for the City of Lambertville Police Department. This report details operational statistics, administrative activities and functions and a general assessment of department productivity in a variety of areas.

2016 continued to be another challenging year for the department, as we continued to operate with a reduction in force of one police officer (10% of department) that took effect in 2011. This staff reduction resulted in the elimination of a dedicated investigator position. This slot had been crucial with respect to our ability to conduct timely and efficient initial and follow-up investigation of reported crimes, and all other type of investigations such as background checks, domestic violence case follow-up, ABC, firearms, taxicab, and vending machine licensing. These responsibilities are presently

assigned to Police Officer Vincent Albani who was recently designated as the department's detective-investigator. However, he remains assigned to the regular duty chart and is still required to perform regular patrol duties and respond to calls for service. Detective Albani also serves as the department's Evidence/Property Officer.

In 2016, the department handled 11,046 calls for service, about a 15% increase over the previous year. This significant increase in call volume is on top of a 17% increase the previous year. Clearly, the demand for police service is on the rise. In addition, extended absences (8 months and 2 months) of two officers due to illness added to the challenge of providing police coverage on a 24/7 basis. We did however manage to somewhat mitigate staffing shortages with the hiring on one full-time special police officer, Jeff Jones, in December. Notwithstanding these difficulties, we still managed to achieve a 15% reduction in paid overtime, a testament to the dedication and perseverance of our members.

The department also managed to achieve an 84% increase in narcotics arrests, a 39% increase in disorderly person arrests and a 28% increase in warrant arrests. Unfortunately, we saw productivity declines in both moving (-7%) and parking (-20%) violations. The drop in parking tickets is attributed to two factors- implementation of the ParkMobile pay-by-phone application which has made it much easier for motorists to avoid meter violations and the continued difficulty involved with finding and retaining qualified people to perform parking enforcement on weekends and weeknights.

In 2016 the department again secured grant funding (\$5,000.00) from the state to participate in a "Click-It-Or-Ticket" seat belt enforcement campaigns. The campaign resulted in the issuance of 63 seat belt and 226 other moving violations.

Parking meter revenue declined by 4.2% for the year. The city implemented a pay by cell phone app, ParkMobile, on April 21 and the usage is gradually becoming more widespread throughout the CBD. At the present time we are averaging about 300 transactions per week and revenue from the program is increasing as well.

Part I UCR crimes in 2016 totaled 67, a 34% increase over 2015. This increase is attributed to a rash of thefts (17) from parked/unlocked vehicles that occurred over a two month (August-September) period. Despite extra patrols and surveillance operations no arrests were made relating to these crimes, which, without the benefit of eyewitnesses or catching a suspect in the act, are extremely difficult to solve. Over the years, the police department has repeatedly put out warnings to residents advising them to lock parked vehicles and not leave any property on seats or in plain sight. Unfortunately, people continue to do just that and these crimes of opportunity continue to occur. It's worth noting that none of these thefts involved forced entry.

A total of four violent crimes, one robbery and three sexual assaults were reported in 2016. Two of the three sexual assaults reportedly occurred several years in the past and

the suspects' whereabouts could not be ascertained, although an arrest warrant was placed on one suspect. The single reported robbery occurred during a domestic violence incident and the perpetrator was arrested. The number of simple assaults went up by two, from 14 in 2015 to 16 in 2016. On a positive note, we did see a decline in burglaries, from 8 in 2015 to 5 in 2016, and there were no aggravated assaults reported during the year.

There were 162 motor vehicle accidents in 2016, compared with 164 accidents reported in 2015. No fatalities resulted from these accidents. Two accidents involved pedestrians and two involved bicyclists. None of those incidents resulted in life threatening injuries. A total of two reported accidents involved a drunk driver. The top two accident locations were once again at the intersections of Routes 165/ 518 (16) and Route 165/179 (5).

In September, the department acquired body worn cameras and associated equipment to outfit all sworn, uniformed police officers. The cameras were partially funded (\$4500.00) through the NJ State Body Worn Camera Assistance Program utilizing state forfeiture funds and enable officers to record virtually all interactions between officers and the public. The cameras must be activated on all motor vehicle stops, arrests, accidents, routine service calls and criminal investigations. Use of the cameras is strictly governed by New Jersey State Attorney General and Lambertville Police Department guidelines, policies and procedures. All officers have been trained and equipped with the cameras which have already proven to be a valuable asset.

Although the responsibilities and challenges to police departments are increasingly demanding, all of our members remain steadfastly committed to providing first-class police service and a safe, secure environment for all Lambertville residents and visitors.



Police Department Accomplishments 2016

- 15% reduction in paid overtime.
- 84% increase in narcotics arrests.
- 39% increase in disorderly person arrests.
- 28% increase in warrant arrests.
- The department applied for and was awarded one overtime reimbursement grant (\$5000) from the NJ Division of Highway Traffic Safety to participate in the Memorial Day "Click-It-Or-Ticket" statewide seat-belt enforcement initiative. The campaigns resulted in 63 seat-belt and 226 other moving violations as well as one arrest for DUI.
- In September, the department acquired body worn cameras and associated equipment to outfit all sworn, uniformed police officers. The cameras were partially funded (\$4500.00) through the NJ State Body Worn Camera Assistance Program utilizing state forfeiture funds and enable officers to record virtually all interactions between officers and the public. The cameras must be activated on all motor vehicle stops, arrests, accidents, routine service calls and criminal investigations.
- Lieutenant Robert Brown was again recognized by MADD at their Summer Law Enforcement Recognition event for outstanding DUI enforcement in 2015.
- In April, the ParkMobile pay by cell phone application became operational and is currently averaging about 300 transactions per week and usage continues to increase. The service has been extremely well received by residents, business owners and visitors.

 In January, Lieutenant Robert Brown, Police Officer Allen Wurpel and Parking Enforcement Officer Michael Vecchio were awarded departmental recognition (Life Saving Award) for their actions on November 5, 2015, in which they resuscitated (CPR) an unresponsive cardiac arrest victim and stabilized him until the arrival of EMT personnel. The officers quick and effective actions were instrumental in saving the life of an individual who may have very well expired had they not rendered their assistance.

ANNUAL TRAINING

All police officers received mandatory in-service, semi-annual training (28hours) in the following areas: Firearms Proficiency, Use of Force, Vehicle Pursuits, Domestic Violence, Pepper Spray-ASP Baton Use and Tactics, Right to Know, Bloodborne Pathogens, Chemical Safety and Hazardous Materials Awareness, AED Certification and Sexual Harassment in the Workplace. Members also attended advanced training at certified academies and training facilities throughout the state in: Criminal Investigation, Basic Crash Investigation Course, Crisis Intervention Team (CIT) training relating to handling emotionally disturbed individuals, Autism and Law Enforcement: Recognition, Response and Risk Management, Active Shooter Drills, Penn State High Impact Supervision Course, NJSP CJIS TAC Officer Update, Uniformed Crime Reporting Update, Evidence Management, and Internal Affairs Investigations.

POLICIES, PROCEDURES, OTHER DIRECTIVES

The Department continued to review existing policies and procedures and updated or promulgated directives as necessary. Policies and procedures were revised and/or promulgated in the following areas: Internal Affairs, Pursuit Procedures/Roadblocks, Criminal Complaints/ECDR Policy, Use of Force, Fatal Accidents/Serious Crash Investigation and Body Worn Camera Policy. Additionally, various Prosecutors' Office directives and Attorney General Directives and/or guidelines were received and disseminated as appropriate.

The Police Director issued three post conditions and eleven personnel orders in 2016. These directives covered areas that include community policing and enforcement activities, directed patrols, post assignments, personnel appointments, special event coverage and other operational and/or administrative subjects.

INTERNAL AFFAIRS SUMMARY

In 2016 the department investigated two (2) citizen complaints and two (2) departmental complaints. One complaint involved employee demeanor and three alleged that officers committed procedural violations. All four complaints were at least partially substantiated and appropriate disciplinary action was taken.

In 2016, an additional three disciplinary actions were taken apart from the aforementioned internal affairs cases to address procedural violations observed by supervisory officers. All resulted in appropriate disciplinary action.
