e. Waste Stream

Cyndy reported the second composting survey for residents has been sent out. This went to the people who agreed to be contacted again.

Liz and Lindsay are working on "what goes in your recycling" sticker, but that would be done after composting issue is addressed. Andy is working on getting estimates for the fridge magnets to potentially be made using Clean Communities funding.

Liz and Kelly are working on "where does your recycling go?" piece of reeducation campaign.

- h. EV Charging Stations

City awarded \$75,000 to install a charger. That will cover one parking spot. It must be used on Union St lot. The City is working with JCPL to see secure a grant to cover the installation costs.

Kate needs to send Kelly info on slow charging.

 Union St. Lot Spruce Up Liz noted the Bowman grant must be used on land owned by the City. The grnat can be used for plantings in the Union St. lot but not privately owned areas.

Lindsey noted the library lot could be a potential site for Bowman's planting.

j. Resiliency

Liz reported the resiliency team is working on a remembering Ida month event that will include a crowd-sourced installation of images at the Acme.

The Mayor wrote a letter on resiliency to be published in Lambertville Matters on what has been done so far and what still needs to be done.

Lambertville Matters will have a storm season preparedness checklist.

Kate noted the NJDEP is offering a Resiliency planning grant opportunity the City should pursue and will work with Liz.

k. Pesticide Ban

Kate sent the Mayor information on other municipal bans and waiting to hear back.

1. Green Business Certification Workshop

Kelly reported no progress at this point.

m. Stormwater Utility Feasibility Study

Kate noted the DEP is offering a grant, however the City does not meet the priority criteria for consideration. Kate and the Mayor met with staff at NJ Future and League of Conservation Voters as LCV has funding through William Penn for Delaware Watershed communities to complete feasibility studies.

n. Sustainability Scorecard

Other cities do report card on their sustainability goals and Kelly has been looking at creating something similar for Lambertville. Could take the shape of a GHG inventory, water use, waste generation.

  - a. NJDOT Rockfall Project

Members of the Commission agreed the safety and environmental data shared by NJDOT was not compelling and members would support a large scale green infrastructure project rather than what is currently proposed.

EC voted(5-0) to support resolution opposing the project.
