The meeting of the Trustees of the Lambertville Free Public Library was called to order at 7:04 PM by Matt Larkin. In addition to Mr. Larkin present were Trustees, Jacqueline Sornstein, Stephanie Volmer, Karen Riedeburg, Rose King, Albert Bauer, Paul Hamilton and Library Director Jen Sirak. Absent were Maureen Smyth and Amy Connelly.

The Friends group is still working on separating from the Acme group and is not yet set up to take donations so a request has been made that the Lambertville Free Public Library accept the funds and once the work is done dedicate the refurbished space to the Friends of the Library. On a motion by Matt Larkin and seconded by Steph Vogel, the Board unanimously accepted the donation of \$10,000. An affirmative voice vote was taken in favor of the motion by all members. MOTION CARRIED. On a motion by Paul Hamilton and seconded by Jacqueline Sornstein an amendment was made to the motion to accept all 2020 donations to the library, including but not limited to donations made by Brett Schniederman, Jane & Bruce Gerhowitz and the Davis Family. An affirmative voice vote was taken in favor of the motion by all members. MOTION CARRIED.

Jen Sirak will provide the Board secretary with the names and addresses of all people who have made donations and the board secretary will write thank you notes.

Ricardo Zapata will be joining the board and will be sworn in at the January meeting.
