iii. Resolution Number 55-2024: A Resolution to Amend the Staff Handbook, Granting Part-Time Employees Vacation Time at a Rate of 1 Hour for Every 30 Hours Worked.

WHEREAS, the Staff Handbook does not address vacation time for part-time employees; and

WHEREAS, it has been past practice to grant part-time employees 1 hour of vacation time for every 30 hours worked.

NOW THEREFORE BE IT RESOLVED by the Governing Body of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey that the Staff Handbook, adopted by Ordinance Number 23-2023 on August 17, 2023, is hereby amended to include a provision to grant paid vacation time to part-time employees at a rate of 1 hour for every 30 hours work.

iv. Resolution Number 56-2024: A Resolution to Appoint Christie Ehret to Serve as the Qualified Purchasing Agent for the City of Lambertville at an Annual Rate of \$2,500.00.

v. Resolution Number 57-2024: A Resolution to Amend the Bulk Garbage Permit Fees.

Whereas, the City of Lambertville met on March 7, 2024, and discussed the 2024 bulk trash removal rates at a public meeting; and

Whereas, the bulk rate trash removal includes employee time, gas, truck maintenance, and tonnage; and

Whereas, the City of Lambertville does not accept the following material as part of our Garbage and Recycling program:

- Air Conditioners recycled annually through the County of Hunterdon's Electronics Recycling (https://www.co.hunterdon.nj.us/261/Recycling-Solid-Waste-Services)
- Gas Tanks
- Construction Debris
- Tires (only during Sparkle Week, two per house)
- House paint. Empty or dried out paint cans can be placed in the garbage. Cans still containing paint must be dried out before disposal. Paint can also be disposed of at a County Hazardous Waste collection event.

Whereas, the Governing Body of the City of Lambertville, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

Whereas, the Governing Body of the City of Lambertville has the need on a timely basis to purchase goods or services utilizing State contracts; and

Whereas, the Governing Body of the City of Lambertville intends to enter into contracts with the attached Referenced State Contract Vendors through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contracts;

Now, Therefore, Be It Resolved, that the Governing Body of the City of Lambertville authorizes the Purchasing Agent to purchase certain goods or services from those approved New Jersey State Contract Vendors on the attached list, pursuant to all conditions of the individual State contracts; and

x. Resolution Number 62-2024: A Resolution Requesting \$76,320.00 from the Lambertville Municipal Utility Authority, Pursuant to P.L. 2204, c.87

WHEREAS, P.L. 2204, c. 87 established a formal procedure for local authorities to transfer funds to their creating government agency; and

WHEREAS, the Lambertville Municipal Utility Authority was created by the governing body of the City of Lambertville; and

WHEREAS, N.J.S.A., 40A:5A-12.1 in part states:

"To the extent there is available an undesignated fund balance or unreserved retained earnings by (a covered authority) ... an amount in that undesignated fund balance or unreserved retained earnings, not to exceed 5% of the annual costs of operation of the authority may be appropriated for use in the local budget of the municipal or county that created the authority unless otherwise restricted by bond covenants;" and

WHEREAS, the law required payments to the municipality shall be made no later than 30 days prior to the close of the municipality fiscal year, or anytime sooner as made by mutual agreement; and

WHEREAS, the City of Lambertville has anticipated the Lambertville Municipal Utility Authority appropriation of \$76,320.00 as a Special Item of Revenue in the proposed 2022 municipal budget.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Lambertville, County of Hunterdon, State of New Jersey does hereby request that the Lambertville Municipal Utility Authority transfer \$76,320.00 to the City of Lambertville.

xi. Resolution Number 63-2024: A Resolution to Authorize the Extension of the Time Period for Valet Parking on North Union Street East of Church Street to May 26, 2024.

WHEREAS, the Governing Body of the City of Lambertville adopted Resolution Number 201-2022 on November 17, 2022, authorizing the three-month trial period for Valet Parking on North Union Street, which was never enacted, and

WHEREAS, the owners of Under the Moon, LLC would like to manage and offer to the public a Valet Service using two metered spaces on the east side of the street, directly in front of Under the Moon; and

WHEREAS, the valet would be managed by Open Door Valet or a vender who is selected by owners of Under the Moon, LLC; and

WHEREAS, the hours of operation are as follows:

- o Friday Night beginning at 5:00 p.m. 10:00 p.m.
- o Saturday beginning at 11:00 a.m. to 10:00 p.m.
- O Sunday 1:00 p.m. through 6:00 p.m.

WHEREAS, the lease for the storage of cars is with Houston-MDL LLC & SLRI Holdings LLC; and

WHEREAS, the trial period began on December 29, 2023, and will end March 29, 2024; and

WHEREAS, Under the Moon, LLC or the Valet Service will record statistics and will submit them to the City monthly for future consideration of the program; and

WHEREAS, after the end of the trial period, the governing body will consider the pros and cons of offering the services and may adopt an ordinance permitting the continuation of valet services at this location; and

WHEREAS, the owners of Under the Moon, LLC are managing this program, however the services will be available to the public; and

WHEREAS, Under the Moon will pay the City \$1.50 per hour, per meter

- Friday night, 5:00 10:00 p.m. = \$7.50 per meter
- O Saturdays: 11:00 a.m. 10:00 pm. = \$16.50 per meter
- \circ Sunday, 1:00 6:00 p.m. \$7.50 per meter

WHEREAS, if at any time, either party decides that the valet services are not in the best interest of the city or the owners of Under the Moon, LLC, either party will end the service with 10 days' notice.

NOW THEREFORE BE IT RESOLVED by the governing body of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that the request for valet services in front of Under the Moon, LLC is hereby authorized subject to the following conditions:

- 1. Shad Festival weekend (April 19 through the 21st) will be excluded from Valet Parking Services.
- 2. The program will end May 26, 2024.
- 3. Under the Moon, LLC will manage the program and will maintain records for submittal to the city monthly.
- 4. Hours of Operation are restricted to the following days and times with a maximum of three metered parking spaces:
 - o Friday Night beginning at 5:00 p.m. 10:00 p.m.
 - O Saturday beginning at 11:00 a.m. to 10:00 p.m.
 - o Sunday 1:00 p.m. through 6:00 p.m.

- 5. Under the Moon, LLC agrees to pre-pay for the use of the parking spaces with \$252.00 due per month, for two meters, based on 4 weekends per month, due the first of each month.
- 6. Valet's may be required to take a pre-approved route for traveling to and from Lambertville Station.
- 7. There will be no parking in the emergency access agreement that runs on the eastern side of the parking lot.
- 8. Valet company will provide a State of New Jersey
 Business Registration, a Certificate of Good Standing
 with the State of New Jersey, or register as a foreign
 company, and provide the City with their Certificate
 of Insurance with the limits that include liability
 insurance and workers compensation.

BE IT FURTHER RESOLVED that the Mayor, City Attorney, and City Clerk are hereby authorized to sign the Memorandum of Understanding with the owners of Under the Moon, LLC.

xii. Resolution Number 64-2024: A Resolution to Authorize the Tax Collector to Cancel the first and second 2024 quarter taxes for Block 1059, Lot 8, 4 Curley Lane, Due to a Tax Exemption.

a. Ordinance Number 04-2024: A Bond Ordinance.

ORDINANCE 04-2024

AN ORDINANCE OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY, PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS OF AND FOR THE CITY, APPROPRIATING \$1,403,053 THEREFOR, AND AUTHORIZING THE ISSUANCE OF \$1,361,538 IN GENERAL IMPROVEMENT BONDS OR NOTES OF THE CITY TO FINANCE THE SAME.

BE IT ORDAINED BY THE CITY COMMITTEE OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The improvement or purpose described in Section 3 of this bond ordinance is hereby authorized to be undertaken by the City as a general improvement. For the improvement or purpose described in Section 3 hereof, there is hereby appropriated the sum of \$1,403,053, including alternate funding sources in the aggregate amount of \$581,598, consisting of a \$131,598.00 New Jersey Department of Transportation Municipal Assistance Grant and a federal reimbursement grant of \$450,000 and utilizing an additional \$503,300 previously appropriated, including a state appropriation of \$500,000 cash-in-hand grant and a builder's contribution of \$3,300 and further including the sum of \$41,515 as the down payment for several purposes as required by the Local Bond Law. The down payment has been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the improvement or purpose not covered by application of the down payment or otherwise provided for hereunder, negotiable bonds or notes are hereby authorized to be issued in the principal amount of \$1,361,538, pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

<u>Section 3</u>. (a) The improvements hereby authorized and the purposes for which the bonds or notes are to be issued are as follows:

I. <u>Purpose.</u> Improvements to City Street and Roads, including but not limited to South Franklin and Church Street, including related work to curbing, grading, drainage and storm water management, including expenses incurred in the planning, design and bidding thereof, and including all work and related materials necessary thereof or incidental thereto.

- (b) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose is as stated in Section 2 hereof.
- (c) The estimated cost of the improvement or purpose authorized herein is equal to the amount of the appropriation herein made therefor.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer, provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8(a). The chief financial officer is hereby authorized to sell part or all of the notes from time to time, at not less than par and accrued interest, at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The capital budget or temporary capital budget (as applicable) of the City is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

<u>Section 6</u>. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are improvements or purposes the City may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The period of usefulness of the improvement or purpose, within the limitations of the Local Bond Law, is 18.03 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the City as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$1,361,538, and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$300,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the improvement or purpose.
- (e) The City reasonably expects to commence the acquisition of the improvement or purpose described in Section 3 hereof, and to advance all or a portion of the costs in respect thereof, prior to the issuance of bonds or notes hereunder. To the extent such costs are advanced, the City further reasonably expects to reimburse such expenditures from the proceeds of the bonds or notes authorized by this bond ordinance, in an aggregate amount not to exceed the amount of bonds or notes authorized in Section 1 hereof.
- <u>Section 7</u>. Any grant moneys received for the purposes described in Section 3 hereof, exclusive of the State Grant already appropriated herein, shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized hereunder shall be reduced to the extent that such funds are so used.
- Section 8. The full faith and credit of the City is hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the City, and the City shall be obligated to levy ad valorem taxes upon all the taxable real property within the City for the payment of the obligations and the interest thereon without limitation as to rate or amount.
- Section 9. The City Committee hereby covenants on behalf of the City to take any action necessary or refrain from taking such action in order to preserve the tax-exempt status of the bonds and notes authorized hereunder as is or may be required under the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder (the "Code"), including compliance with the Code with regard to the use, expenditure, investment, timely reporting and rebate of investment earnings as may be required thereunder.
- <u>Section 10</u>. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
