## PUBLIC PARTICIPATION

Councilwoman Lambert asked where we are with an appraisal for the Closson property. Mayor Fahl responded that the previous council chose not to get an appraisal due to various reasons: concerns about the appraisal process; the City will need to obtain appraisals for the Green Acres application and the application to the Hunterdon County Land Trust for the open space; the City received input from information about different kinds of values. Councilwoman Lambert asked if that information was shared with the public. The City Attorney clarified that the information was presented to council; and is not shared directly with the public because of some proprietary documents, attorney client privileged, and if we don't acquire we don't want to hurt their ability to negotiate another sale.

Evan Lide: with regard to the Closson property, a lot of discussion about elementary school, questioning if we might be able to build a school on there. I would assume that limits. Has there been discussion about buying it a different way to build a school? Mayor Fahl responded that the City has not had a request from the school; but this is in hands of the board of education. This would limit the professed goal that this council had to maintain the rural of our community but the City is willing to hear them out.

Councilman Sanders responded that if we were to purchase the property and if it were used for the new school, it would be used by West Amwell and Stockton as well, and that is a different tax base.

Discussion regarding an appraisal for the Closson property ensued. The discussion regarding spending funds, approximately \$15,000, for the appraisal continued. This will be on the March 18 meeting agenda for discussion.

Paul Stevens: asked about the resolution on the agenda for adoption that was moved to Tuesday, will the particulars be updated prior to the meeting? Mayor Fahl responded that we received the information hours before this meeting and we have been trying to provide agendas that are 20 or 30 pages long, to give sunlight, we couldn't hit the mark because how quickly this project turned around. We will post it as soon as it becomes available.
