A Resolution Authorizing Application for a 2022 Sustainable Jersey® Grant funded by the PSEG Foundation in the amount of \$20,000 to Transform Lambertville's North Union Street Park

WHEREAS, the City of Lambertville recognizes the importance of improving the environment in the City for its residents;

WHEREAS, the City of Lambertville faces ongoing challenges due to flooding caused by stormwater impacts, heat island effects due to development, and the loss of Ash trees due to Emerald Ash Borer;

WHEREAS, the North Union Street Park, acquired in 2011, is currently primarily an unimproved area of mowed lawn with no trees on the property;

WHEREAS, unprogrammed recreational space is at a premium in the City of Lambertville and preserving a portion of mowed lawn is desirable;

WHEREAS, naturalizing through the planting of trees and native perennial ground cover around the perimeter of the North Union Street Park will intercept, infiltrate, and naturally purify stormwater falling onto and flowing across the site, mitigate the heat island effect in and around the City through shade and evapotranspiration, improve the City's urban forest, and provide wildlife habitat;

WHEREAS, the City of Lambertville recognizes the importance of preserving, enhancing and installing wildlife habitat and was been designated as a Certified Community Wildlife Habitat by the National Wildlife Federation in 2019;

WHEREAS, resident volunteers with Lambertville Goes Wild, and Lambertville's Environmental and Parks and Recreation Commissions have installed a wildlife habitat garden along the northern edge of the park on October 12, 2019 through a grant from the Association of New Jersey Environmental Commissions;

WHEREAS, resident volunteers continue to successfully maintain and cultivate the wildlife habitat garden along the northern edge of the park;

WHEREAS, Ordinance Number 01-2011 passed in 2011 to formally purchase and preserve the North Union Street Park is protected open space and improving the North Union Street Park as described above is a desirable and sustainable land management practice;

§ 7-4.4 Parking Prohibited Certain Hours.

[Ord. #88-25, § 5; Ord. #90-02, § 1; Ord. #94-16, § 3, Ord. #97-20, § 1; 1990 Code § 7-4.4.]

WHEREAS, In full compliance with the Clean Communities Grant, the city of Lambertville prohibits parking during certain hours for the purpose of running the street sweeper;

WHEREAS, the street sweeper, overseen by the Department of Public Works, has many values that improve quality of life for the residents and wildlife in our city; and helps to protect the Delaware River, and

WHEREAS, the public works department has requested that the city review this policy to increase the prohibition of parking and to make all hours the same throughout the city.

NOW THEREFORE BE IT RESOLVED by the governing body of the city of Lambertville that the prohibited hours for parking in section 7-4.4, Parking Prohibited Certain Hours is here by changed to read:

Hours: 8:00 am to 10:00 am on all streets listed in section 7-4.4 for the purpose of running the street sweeper and keeping the city's streets free from debris.

Removing the following streets: Hancock Street, Lincoln Street, Quarry Street, South Franklin Street, Studdiford Street and Swan Street from Route 165 to Brunswick Avenue.
